

MHbuddy's Enrich Gift 4 Buddies

Terms & Conditions

1. **The Enrich Gift 4 Buddies Promotion ("Promotion") is organised by Malaysian Airline System Berhad ("MAS") and will run from the 3rd January 2012 to 31st March 2012**
2. **The promotion is open to all Enrich members (Eligible Participants) who have booked their flights on MHbuddy ONLY.**
3. **The mechanism of the promotion is as follows;**
 - **Enrich members who have booked their flights on MHbuddy will receive an additional 1,000 Enrich Miles**
