

Enrich – Double Elite Miles Malaysia Airlines Grand Travel Deal Campaign (April 2018) Terms and Conditions

- 3. Elite Miles may not be used towards the redemption of Enrich Awards or can they be transferred, extended, purchased, sold or given to another member. Elite Miles is valid only for this calendar year (January December 2018) in which they are earned and are not accumulative.
